Calls upon all residents to honor the service of LGBTQIA+ veterans, support their pursuit of justice, and celebrate their enduring contributions to our nation and our community. (State Government Administration RBA)

H.R. 796 -- Gabel --- Declares May 12, 2026 as Myalgic Encephalomyelitis Awareness Day in the State of Illinois. Encourages increased public education and awareness efforts regarding Myalgic Encephalomyelitis (ME), support for individuals and families affected by the disease, and continued attention to research and health care initiatives aimed at improving diagnosis, treatment, and quality of life for those living with ME. (Public Health RBA)

H.R. 803 -- Stava --- Declares July 28, 2026 as Hepatitis B Awareness Day in the State of Illinois. Urges promotion of hepatitis B vaccination as a highly effective and safe public health measure and supports removal of barriers to vaccination. Encourages development of an effective and actionable state hepatitis B strategic plan, as well as establishment of a hepatitis B working group to develop measurable goals. (Public Health RBA)

Order of Resolutions

H.R. 810 -- Grasse --- Declares July 10, 2026 as Vaccine Awareness Day in the State of Illinois to continue educating the public on the importance of vaccination, initiate meaningful dialogue around vaccination, and encourage the uptake of recommended vaccines. Urges the Illinois Department of Public Health (IDPH) to inform healthcare providers and Illinois residents that vaccinations are a highly effective and safe public health measure and to increase public awareness about the importance of all Illinois residents receiving immunizations as recommended. Urges IDPH to specify the differences between recommendations from the Advisory Committee on Immunization Practices (ACIP) and those issued by professional medical societies and to promote vaccination outreach and education initiatives that emphasize the importance of communication between patients and healthcare providers. Urges IDPH to continue prioritizing immunization initiatives and policies and to invest in immunization infrastructure to ensure broad and open access to immunizations. Urges IDPH to strengthen the State's public health preparedness, encourage the promotion and sharing of evidence-based vaccine recommendations, improve cross-state collaboration, and respond effectively to federal vaccine policies that lack scientific basis. Urges the Governor to explore joining a multi-state public health collaborative. (Public Health RBA)

Order of Resolutions

H.R. 811 -- Davis, Will - Keicher - Williams, Jawaharial - Cabello - Hanson --- Reaffirms the commitment to the strengthening and deepening of the sister-state relationship between the State of Illinois and Taiwan, the Republic of China (ROC). Reaffirms support for the Taiwan Relations Act (TRA) and supports Illinois businesses referring to Taiwan as "Taiwan". Endorses Taiwan's efforts to secure the signing of a Bilateral Trade Agreement (BTA) and the Avoidance of Double Taxation Agreement (ADTA) with the United States. Supports the further strengthening of a closer economic and trade partnership between the State of Illinois and Taiwan with multiple possible approaches, including signing an economic and trade memorandum of understanding, exploring the possibility of establishing an Illinois Office in Taiwan, and sending Illinois high-level officials to visit Taiwan without being threatened by any adversary forces. Supports Taiwan's meaningful participation in international organizations, which impact the well-being of the peoples of Taiwan, the State of Illinois, the U.S., and the world. Opposes any distortion or misuse of UNGA Resolution 2758 to attempt to deny Taiwan's aspiration to make contributions in international societies. (Int Relations, Tourism, & Trade RBA)

H.R. 815 -- Johnson - Cabello --- Urges the Illinois Department of Corrections and the Office of the Architect of the Capitol to establish a Corrections Fallen Heroes Memorial on the State Capitol grounds. Recognizes the inherent danger and risk that correctional employees confront daily while serving a critical public safety mission. Affirms that the State's fallen heroes are deserving of a public memorial honoring the sacrifice they made. (Executive RBA)

H.R. 821 -- Manley - La Ha - Blair-Sherlock - Swanson - Hanson --- Declares April 2026 as Autism Awareness and Acceptance Month in the State of Illinois to help increase public awareness of the need to support individuals with autism and the family members, medical professionals, and human services professionals who help care for individuals with autism. (Human Services RBA)

H.R. 823 -- Canty - Swanson - Harper - Meier - Bunting - -- Declares May 6, 2026 as Illinois Bacon Day in the State of Illinois and invites all Illinoisans to thank a pig farmer by enjoying some delicious slices of bacon. (Agriculture & Conservation RBA)
