A BILL FOR

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much thereof
6 as may be necessary, respectively, for the objects and
7 purposes hereinafter named, are appropriated to meet the
8 ordinary and contingent expenses of the Department of
9 Innovation and Technology:

10	PAYABLE FROM THE GENERAL REVENUE FUND	
11	For Personal Services.....	29,858,700
12	For State Contributions to Social Security.....	<u>2,284,200</u>
13	Total	\$32,142,900

14 Section 5. The sum of \$257,000,000, or so much thereof as
15 may be necessary, is appropriated from the General Revenue
16 Fund to the Department of Innovation and Technology for
17 administrative and program expenses, including prior years'
18 costs.

19 Section 10. The amount of \$2,000,000, or so much thereof
20 as may be necessary, is appropriated from the General Revenue
21 Fund to the Department of Innovation and Technology for all

1 costs associated with the Cybersecurity Liaison Program.

2 Section 15. The sum of \$718,869,700, or so much thereof as
3 may be necessary, is appropriated from the Technology
4 Management Revolving Fund to the Department of Innovation and
5 Technology for administrative and program expenses, including
6 prior years' costs.

7 Section 20. The sum of \$5,000,000, or so much thereof as
8 may be necessary, is appropriated from the DoIT Special
9 Projects Fund to the Department of Innovation and Technology
10 for all ordinary and contingent expenses related to
11 information technology within the powers and duties of the
12 Department.

13 Section 25. The sum of \$25,000,000, or so much thereof as
14 may be necessary, is appropriated from the DoIT Special
15 Projects Fund to the Department of Innovation and Technology
16 for all ordinary and contingent expenses related to addressing
17 cybersecurity risks and cybersecurity threats as authorized by
18 Section 70612 of the Infrastructure Investment and Jobs Act,
19 (IIJA) and any associated federal guidance.

20 Section 30. The amount of \$20,000,000, or so much thereof
21 as may be necessary, is appropriated from the Personal
22 Property Tax Replacement Fund to the Department of Innovation

1 and Technology for all costs associated with the Illinois
2 Century Network and broadband projects.

3 Section 99. Effective date. This Act takes effect July 1,
4 2025.
